

**ACKNOWLEDGEMENT OF REQUIREMENTS FOR PARTICIPATION IN THE PROGRAM FOR ACADEMIC  
VISION AND EMPOWERMENT (PAVE) PROGRAM**

Oral Roberts University (ORU) has provided students with a unique opportunity to achieve success in receiving their college education by establishing the PAVE Program. I request participation in the Program and acknowledge that the following are conditions of participation in the Program. My failure to adhere to any one of the requirements of the Program may result in the termination of my participation in the Program and/or enrollment at ORU. As a participant in the PAVE Program:

1. I understand that in order to satisfy the requirements for the developmental courses, Math 099 and READ 099 or the COMP 101 course, and to build my academic skills, my participation in the Summer Lead In program taking place on campus August 1-19, 2022 is required.\*

\*Lead In is required at an additional cost to the student of \$950, which includes tuition for 7 credit-hours and housing, but does not include books or meal plan option.

2. I understand that I will be required to complete the Reading Placement Exam that will be offered during the months of May, June, and July to determine which English course I will take. Test dates and registration can be found at [go.oru.edu/LeadIn](http://go.oru.edu/LeadIn).
3. I understand that successful completion of Lead In may qualify me for an ORU Integrity Loan and/or an increase to my Quest Whole Leader or Academic Scholarship\* as follows:

5. I will comply with the course professor's required class attendance policy. I will attend all classes regularly and punctually, understanding that failure to comply with the attendance policy stated by each individual professor will negatively affect my grades.
6. I am required to complete all tutoring sessions as indicated by the course syllabi.
7. I cannot drop or withdraw from any courses listed in the Program curriculum.
8. My adherence to the Program requirements will be monitored frequently by the use of progress reports. A final grade check will be performed at the end of the semester to determine my compliance with the Program's requirements.
9. I will attend the required study hall at least two hours a week every semester I am a part of the Program.
10. By the end of the semester, I must achieve the following minimum criteria:
  - a. Pass all classes with a grade of a C or better; and
  - b. **Obtain a minimum grade point average (GPA) of 2.0**
  - c. **Failure to meet ALL of the above-mentioned criteria by the end of my first semester may result in being officially suspended from further enrollment at ORU.**
11. I will confer frequently with Dr. Stubbs, the program coordinator, and my professors, as they deem necessary.
12. Dr. Stubbs will create my schedule every semester I am a part of the Program. This schedule will be designed following course requirements for the Program and my major.
13. My educational record information will be provided by ORU to my parents and/or legal guardians regarding my performance in the Program, which shall include grades and progress reports. I have signed the attached FERPA form authorizing release of this information and I understand that in the event I subsequently revoke or withdraw the FERPA authorization to release information to my parents and/or legal guardian, my eligibility for participation in the Program will also terminate at that time.
14. I understand that upon written notice, ORU may alter or amend the requirements and terms of the Program at any time.
