Pass Rate = "Number Passed" divided by "Number Tested," expressed as a percentage.

Statewide Pass Rate = "Number Passed" for all institutions divided by "Number Tested" for all institutions, expressed as a percentage.

Aggregate Rows

Number Tested = Number of program completers who took at least one test in the category within the five-year testing window. For content area categories, this includes only those tests appropriate for a program completer's reported certification field(s).
