FINANCIAL GUARANTEE FORM



United States Department of Homeland Security (DHS) regulations require documentation that sufficient financial resources are available to meet a student's prospective educational and living expenses while in the U.S. Therefore, Oral Roberts University requires a guarantee of financial resources from each applicant who expects to obtain or maintain Student (F-1) status. Applicants are required to submit financial documentation that equals or exceeds one full year of expense for the program of study they are interested in pursuing. Adjustments in the financial certification cannot be made based on a student's individual circumstances. This estimate is based upon 12-18 hours each semester for undergraduate studies or 9 hours each semester for graduate studies. A Certificate of Eligibility (Form I-20) will not be issued until this information is provided. Financial documentation is valid for six months from date of signature on this form or date of bank statement submitted.
