

## HONORS CONTRACT FOR A REGULAR COURSE AT ORU

To be eligible for honors work in a regular course a student must have permission of the professor and must normally have a minimum cumulative GPA of 3.5. This form must be completed, signed by student, professor, and an Honors Program Director and submitted to the Honors Program office (GC 5C06) no later than two weeks before the semester begins. Copies should be retained by all parties.

Honors work normally involves independent research and/or writing in addition to, or instead of, the normal requirements of the course. Specific expectations are flexible, but we recommend the following:

- At least two conferences between students and professor to plan and discuss the honors work;
- Encouragement for the student to probe the course content more deeply and independently than might otherwise be required, not merely read or write more;
- Opportunity to apply the knowledge acquired in the course in ways that might not be required of other students (e.g. by evaluating secondary literature or by laboratory work);
- Opportunity to share the results with the class (e.g. by presentation or web posting).
