### GENERAL EDUCATION COURSES

#### American History Survey 101

This is a broad and brief view of American History from the colonial period to the present. It is a three hour course and is an individually taught class and I am responsible for all aspects of the course.

#### American Government Survey 101

A study of the institutions and process of American Government and politic at national, state and local levels, with attention to policy making by national government along with the relationship between citizenship and Christian faith. We also include as a requirement 5 hours of community service. This is a three hour course taught every semester. I have sole responsibility for lecture, testing, etc.

### UPPER DIVISION COURSES

#### Gov 331 Western Political Theory

This is a study of the great political thinkers from Plato to the present. The course examines the spread of Christianity and the development of political theory, institutions, and concepts of justice and law in the West.

#### History 201: Historiography

Introductory course for history and pre-law majors, the focus is on the student as the central figure for "building history from the ground up." Participants are introduced to the discipline of history and to the historian's craft. Special attention is given to the vocational potential of history major and to the relationship between the field of history and law.

History 343: Civil War and Reconstruction

A study of the political, social, economic, and intellectual roots of the Civil War, the war itself and the period of Reconstruction during the decade following the war.

History 345: United States Since 1929

A study of the New deal and World War II, international politics and the cold war, recent domestic politics, cultural and intellectual trends, and the U. S. in a global perspective.
