



### **Native American Nursing**

July 2020 – began the process of research for the development of an American Indian-Alaskan Native (Al-AN) nursing program with the support of Dean Jezek. This occurred in collaboration with Bev Warne, Mary Isaacson and Valeriah Big Eagle of South Dakota State's Native American Nursing Education Center (NANEC – see <a href="https://www.sdstate.edu/native-american-nursing-education-center">https://www.sdstate.edu/native-american-nursing-education-center</a>). The plan is for a state-wide organization with several mentoring chapters in colleges and universities at all nursing levels. The proposed goals are: 1) to mentor Al-AN nursing students; 2) encourage higher education among native nurses; 3) facilitate better healthcare and healthcare access to the tribes and 4) Al-AN student rentention in all levels of nursing education.

August 2020 – recruited the efforts of Dr. Diana Mashburn at Northeastern State University in Muskogee, OK and Dr. Rachel Mack of Frontier University, OKC. They have agreed to be a part of the planning process with me. After the initial interest meeting in October 2020, we plan to organize an Advisory Council with full launch no later than Fall 2021.

September 2020 - brown bag interest meeting invite developed for Tuesday, October 27 from 12-1p CST and sent to nursing educators across OK.

September 9, 2020 – asked to join a committee of Native American and Alaskan Native nurses by Bev Warne of South Dakota State in developing curriculum for AARP. The Committee Facilitator is Scott Tanaka of the AARP Public Policy Institute. The curriculum will be used in a workshop about Al-AN Nurse Mentoring.
