Collecting and analyzing data from SEF Age/Stage Model of spiritual formation and discipleship assessment tool that has been recently implemented and integrated into the GSTM Assessment Program for all levels of graduate degree programs (PhD, DMIN, MA). Evaluating and comparing multiple variables of spiritual formation and discipleship between and within degree programs.

Collected and analyzed a vast amount of data annually assessing trends in juvenile crime, arrest rates, gang affiliation, demographics, and multiple other variables. Used the findings and results to present, educate, inform, and support civic leaders, juvenile justice, law enforcement, schools, and families in an effort to reduce recidivism among juvenile offenders. Developed weekly, monthly, quarterly, annual reports, fact sheets, assessment and statistical reports from the research data. Reports were used to conduct numerous presentations and training in Oklahoma to acquire funding for the center, train law enforcement, educate civic and community leaders and school officials, and develop strategies for helping youth and families.
