## ORAL ROBERTS UNIVERSITY ACADEMIC COUNCIL MINUTES

September 21, 2015 – 11:00 a.m., GC 3112

1. **TOPIC:** Opening

Dr. Kathaleen Reid-Martinez, ORU Provost and chair of the Academic Council, opened the meeting with a welcome and prayer.

2. **TOPIC:** Approval of Minutes of meeting on August 17, 2015

**DISCUSSION AND CONCLUSION:** Written minutes were distributed to the Council along with the agenda for the meeting. Move for Acceptance by Dr. Tim Norton, seconded by Dr. Kimi Boyd. Approved unanimously.

3. **TOPIC:** Provost Update

**DISCUSSION AND CONCLUSION:** Dr. Kathaleen Reid-Martinez reported on her trip to China with Jenny Fang. She met Bob and Nicole Wang who are on the ORU campus this week sharing in the College of Business. Dr. Reid-Martinez also met with the members of the Ministry of Education in China. The ORU Whole Person Education concept was received favorably for Chinese students. ORU's five learning outcomes aligned perfectly with the Chinese educational goals.

The initiative to create a Chinese Leadership Institute at ORU is going well. The two week Bible Institute courses can be taken for certificate purposes or for up to six hours of university credit. The primary emphasis of the program will be in theology and business. The dates for the Institute are February 8 - 20, 2016.

A good visit was also conducted in Singapore. We can advertise and recruit for ORU online programs in Singapore without government registration, but will not be allowed to provide any on-ground or blended classes unless we do register with the government. A meeting with ORU alumni in Singapore was beneficial in providing an understanding of the highly competitive educational environment in their country.

The last part of the Provost's trip was in Geneva, Switzerland. The focus of meetings was on the creation of a Global Knowledge Network that could support global communities of programs to support efforts to solve problems that are difficult or seem impossible to solve. Core to the discussion was the role of integrative learning and the role of global virtual networks in that educational process. The real-world application of ideas is critical in this environment. The flipped classroom is one example of a learning approach that approximates this type of problem solving. A related problem that was used as a key example was the migratory wave of refugees throughout Europe, which creates challenges

on all levels within the cultures and demonstrates the need for integrative learning to include adult and professional education to assist immigrants to enter societies.

4. **TOPIC:** Mode of Operation for Academic Council Meetings
