1. TOPIC: Opening

3. **TOPIC:** Update from the General Education Curriculum Committee – Dr. Andy Lang

DISCUSSION: Dr. Lang presented the following items from the previous General Education Curriculum Committee's meeting:

- New GEN Special Topics Courses (GEN 368 and GEN 468) unanimously passed the General Education Curriculum Committee's acceptance as a GEN Special Topics course. These will be housed in the Department of English and Modern Languages. .
 (Note: All colleges may use these course listings for General Education special topics. After college approvals, the proposed topic is reviewed by the General Education Committee to ensure its fit and purpose as a General Education course.)
 - a. A vote was taken to accept these two courses. Dr. Gary motioned; Dr. Attah seconded.

b. Renaming of COM 346 and GEN 346 (from "Business & Professional Speech" to "Corporate & career Communication"). Dr. Gary motioned; Dr. Huntley seconded.

c. New Scaffolded Interdisciplinary Course (SIC): HIS/GEN 309 – History of Apologetics. Dr. Gary motioned; Dr. Huntley seconded.

d. Updated Catalog wording regarding exemption to the foreign language requirement for speakers of languages other than English. The updated ORU Catalog states, "However, those who can demonstrate proficiency in a language other than English may petition for a waiver from the foreign language requirement. The foreign language waiver exempts the student from the course(s) but does not contribute credit hours towards the student's degree." Dr. Wheat motioned, and Dr. Johnston seconded.

e. Cross-list GEN 344 with THE 404 – C.S. Lewis: His Life and His Legacy. Dr. Libertus motioned; Dr. Prentice seconded.

ACTION: Dr. Foster will engage in a conversation with college faculty members about the "History of Apologetics" course. Subsequently, he will communicate with the Academic Council and/or the General Education Curriculum Committee about the potential of developing a specific SIC Apologetics course. Additionally, Dr. Reid-Martinez will inquire with the International Student Center office about how to best communicate with international students regarding the foreign language requirement. Lastly, the Provost Office will explore the challenges affecting team-taught 400-level General Education courses.
