**<u>ACTION:</u>** Motion to separate out the 120 hour proposal for discussion, seconded—majority vocal support of action; a few against; and 0 abstain; proposal separated out from report accepted

**ACTION:** Motion to separate approval of 120 hour reduction for Nursing degree away from the acceptance of the 120 hour reduction for new online programs, creating two separate motions; seconded by Marcia Livingston—majority vocal support of action; a few against; and 0 abstain; separation accepted

**ACTION:** Motion to move the voting on the two proposals to an electronic vote over a period of time—59 support of action; 36 against; and 0 abstain; electronic vote accepted

**ACTION:** Motion for an electronic vote on the separate motions over a two week period—majority support of action; a few against; and 0 abstain; two week period accepted

### PROVOST'S SUMMARY REPORT OF ORU ACADEMIC COUNCIL MINUTES Meeting Dates: April 11 and 15, 2016

The Academic Council meeting began with prayer and then tended to the following items:

The Awards Committee's report provided a number of concerns to the Council, including what kind of faculty research could be considered, clarification on the award nomination process, and how tie votes could be broken. In response to the report, the Academic Council established an ad hoc sub-committee to study the proposal and make recommendations back to the Academic Council in the fall. In the meantime, the Provost will break tie votes, should the need arise.

The Whole Person Christian Worldview Committee expressed appreciation of the good response rate of faculty to the Christian World View survey, which was distributed electronically in March. As of last week, 119 faculty members had completed the survey. Results of the survey have not yet been compiled.

The Council received a draft for the definition of Intercultural Experience that was based on comments provided by faculty, including comments from this past semester's faculty Wiki that was designed to collect the information.

Draft of Intercultural Experience Definition based on Faculty Comments: Encounters, interactions, and involvement among people from different cultural backgrounds, countries, or regions of the same country that develop students' cognitive, affective, behavioral skills and attitudinal responses.

Council members will take the draft of the definition to their colleges for discussion during the fall.

The Academic Council received a proposal from the College of Science and Engineering requesting that the university policy change from a minimum of 128 credit hours to a minimum of 120 credit hours for graduation with an undergraduate degree. Key points included:

- 1. The proposal **does not require** the reduction in credit hours for any ORU degrees.
- 2. The 120 hour total is in line with 50% of bachelor degree programs in the US according to a study conducted by Complete College of America.
- 3. HLC Assumed Practices and the Oklahoma State Regents have no problem with the 120 hour total and would likely applaud it, but neither of them requires it at this time.

In the discussion, the College of Nursing indicated their support for the College of Science and Engineering proposal, since they are facing pressure from their specialized accrediting agency to reduce the number of credit hours for graduation.

Due to the sensitive nature of this proposal, the Academic Council decided to table the motion, in order to give council members time to meet with their colleges and to return with their collective thoughts on Friday, April 15th.

During the April 15 Academic Council meeting, the College of Science and Engineering representatives withdrew from consideration by the Council their proposed change to the university policy to decrease the minimum credit hours for graduation requirements from 128 to 120 credit hours.

After withdrawal of the College of Science and Engineering proposal and after discussion that included the desire to respect the review currently in process by the General Education Curriculum Committee, the Academic Council did approve the following policy with 18 votes supporting, 1 objecting, and none abstaining:

An exception should be granted to the ORU policy of a minimum of 128 total hours in an undergraduate degree allowing the total to be reduced to a minimum of 120 total hours for new online programs and to reduce the minimum to 120 total hours for the Nursing degree subject to approval by the General Education Curriculum Committee.

Note, this policy allowing for exception does not apply to all degrees, but only to *new* online programs and the College of Nursing. The rationale for approving new online programs was that new online programs with a minimum of 120-credit hours would reduce their programs by removing electives, while these online programs' general education requirements would remain the same as in current practice. This approach allows the online programs to be more responsive to the needs of adult learners, while still upholding the university General Education requirements.

The rationale for approving the College of Nursing as an exception was that the college could serve as a case study for how the college and General Education Committee can work with the pressures from external agencies in order to assure compliance and alignment with the General Education program that supports the mission and vision of the university.

University policy continues to require that any change to General Education go through the General Education Curriculum Committee and, if needed, through the Academic Council; thus any changes in Nursing will be worked in detail with the General Education Curriculum Committee. All other new programs, including online programs, must be designed with General Education requirements to follow current practices. The Office of Institutional Effectiveness must continue to assure accreditation compliance for all new programs, including adaptation of existing programs into the online environment.

The Academic Council *strongly supports and respects the General Education Committee three-year review process* that is currently in place. In no way is this change to hinder the process. The two groups allowed exceptions will work closely to assure support of General Education requirements and accreditation compliance.

As noted above, this change does not require any undergraduate program to reduce its current credit hours. It, also, does not require any undergraduate program in the future to be limited to 120 credit hours.

The Academic Council realizes that future discussions are needed on such topics as the role of liberal arts education and reduced minimum credit hour requirement for graduation. In response to this, the Academic Council will engage in a research and discussion to learn best practices related to current trends in higher education. This will help to assure that informed academic changes and decisions will continue to support the university mission and vision.

Additionally, the Academic Council encourages and supports, when needed, electronic discussions and votes, in order to continue important academic dialogues and to assure that decisions are made in a timely manner.

Announcement and other information from this past week's meetings included:

- Academic Council meeting dates for the academic year 2016-2017 were provided and approved.
- Colleges that had completed their faculty elections for Academic Council and Academic Council committees were shared. The list of faculty members and their assignments can be found in the Academic Council Minutes for April 11, 2016.
- Dr. Reid-Martinez reminded everyone of the Lunch and Learn held April 11th in the Trustees' Dining Room.
